## Justice U.C.Dhyani (Oral)

By means of present claim petition, petitioner seeks the following reliefs:

"i) Issue an order or direction calling for the record and granting the

pension benefit as per orders of the Govt.

ii) Issue an order or direction calling for the record and to direct the respondent to pay the LIC, transfer T.A., refund of car allowance

and medical reimbursement with 12% interest at an early stage.

iii) Issue any suitable claim, order or direction which this Hon'ble

Tribunal may deem fit and proper in the circumstances of the

case.

iv) Award the cost of claim petition to the petitioner."

2. But, at the very outset, Dr. N.K.Pant, Ld. Counsel for the

petitioner submitted that the petitioner has moved a representation (Annexure:

A-16) to the District Development Authority, Nainital (Respondent No.3), on

29.01.2022, for redressal of his grievances and a direction be given to such

respondent to decide the representation of the petitioner, in accordance with

law, at the earliest, as the petitioner is facing great hardship. Ld. A.P.O. has no

objection to such innocuous prayer of Ld. Counsel for the petitioner.

3. Ld. counsel for the parties submitted that Single Bench of the

Tribunal can pass such an order.

4. The claim petition is disposed of, at the admission stage, with the

consent of Ld. counsel for the parties, by directing Respondent No.3 to decide

pending representation of the petitioner by a reasoned and speaking order, as

per law, without unreasonable delay, and in any case within 08 weeks of

presentation of certified copy of this order along with representation, enclosing

the documents in support thereof. No order as to costs.

5. Rival contentions are left open.
