JUDGMENT

Justice U.C.Dhyani (Oral)

By means of present claim petition, petitioners, *inter alia*, seek to direct the respondents to grant promotion to the petitioners with effect from 24.04.2022, with all consequential benefits including arrears of difference between pre-revised pay scale and revised pay scale.

- 2. Petitioner No.1 is working as Heavy Crane Operator in the respondent department. Petitioner No.2 was working as Master Molder in the Industrial Establishment, Roorkee, Haridwar.
- 3. Respondent No.4 issued seniority list dated 10.02.2022 of the employees of Industrial Establishment under Irrigation Workshop, Roorkee, in which the names of the petitioners have been mentioned (Copy of seniority list dated 10.02.2022: Annexure- A-1).
- 4. Respondent No.4 issued an Office Memorandum on 09.03.2022, wherein it has been mentioned that in industrial establishment of workshop, 06 posts of Foreman are vacant for the employees in pre-revised pay scale of Rs. 5200-20200- grade pay Rs.2800/- to Rs.9300-34800 grade pay Rs. 4200/- and if any eligible employee has objection regarding promotions of these eligible employees, then he can submit his written objection up to 14.03.2022. After such prescribed time, no action shall be taken on the objections of any eligible employee. (Copy of Office Memorandum dated 09.03.2022: Annexure- A-2).
- The said committee took a decision on 27.04.2022 to grant promotion to the eligible employees from the pay scale of Rs.2800/- level 05 to the pay scale of Rs.4200/- level 06. Respondent No.4 mentioned in letter dated 27.04.2022, that no promotion shall be granted unless the employees place an order that the court case pending before Hon'ble High Court has been withdrawn. (Copy of letter dated 27.04.2022: Annexure- A-3).
- 6. Hon'ble High Court of Uttarakhand *vide* judgment dated 08.07.2022, allowed the petitions of the petitioners by a common judgment (Annexure: A-5). Petitioners filed a writ petition before Hon'ble High Court, being WPSS No. 681/2023, Bachan Singh and others vs. State of Uttarakhand and others, which writ petition was dismissed by the Hon'ble Court *vide* order dated 02.05.2023, on the ground of alternate remedy (Annexure: A-6).
- 7. Petitioners preferred intra-court appeal, which was dismissed *vide* order dated 22.05.2023 (Annexure: A-7).
- 8. According to the petitioners, Respondents cannot impose any condition for withdrawing the case, upon the petitioners. It is obligatory on the

part of Respondents No. 3 & 4 to grant promotion to the petitioners as per

recommendation dated 27.04.2022, but the said respondents have not issued

any promotion order of the petitioners. Hence, present claim petition.

9. The claim petition is supported by the affidavit of Sri Chetpal Giri,

Petitioner No.2. Relevant documents have been filed in support of the claim

petition.

10. The claim petition has been contested on behalf of respondents,

by filing written statement by Ld. A.P.O. Counter Affidavit has been filed by

Sri Digaram, Assistant Engineer, Irrigation Workshop, Roorkee. The material

averments contained in the claim petition have been denied in such C.A. The

C.A. is supported by the relevant documents. Rejoinder Affidavit thereto has

also been filed on behalf of petitioners.

11. Ld. Counsel for the petitioners submitted that for redressal of

their grievances, they want to make a representation to Respondent No.2, who

should be directed to decide their representation as early as possible, in

accordance with law. Ld. A.P.O. has no objection to such innocuous prayer.

12. Ld. Counsel for the parties submitted that such an order can be

passed by Single Bench of the Tribunal.

13. The claim petition is disposed of, with the consent of Ld. counsel

for the parties, by directing the Respondent No.2 to decide representation of

the petitioners by a reasoned and speaking order, as per law, without

unreasonable delay, preferably within 12 weeks of presentation of certified

copy of this order along with representation, enclosing the documents in

support thereof. No order as to costs.

14. Rival contentions are left open.
