## **JUDGMENT**

## Justice U.C.Dhyani (Oral)

Petitioner is a retired Traffic Superintendent, Uttarakhand Transport Corporation. She has filed present petition for directing the Respondent Corporation to make payment of Transfer T.A.. According to

the petition, she was transferred from Lohaghat to Dehradun, but Transfer

T.A., along with interest, has not been paid to her so far. Ld. Counsel for the

petitioner drew attention of the Bench towards Annexure: A-1 to submit that

Deputy General Manager (Operation), Uttarakhand Transport Corporation,

Dehradun has already forwarded Transfer T.A. bill of the petitioner for

payment to the Assistant General Manager (Finance), Uttarakhand Transport

Corporation, H.Q. Dehradun

2. Ld. Counsel for the petitioner submitted that petitioner will make

a representation to the General Manager, Uttarakhand Transport Corporation,

who should be directed to decide such representation.

3. Notice has been received by Ld. A.P.O., on behalf of

Respondent No.1. He submitted that there is no provision for interest on

delayed payment of Transfer T.A. He has, however, no objection, if a

direction is given by the Bench to the authority concerned for deciding the

representation of the petitioner, as per law.

4. The innocuous prayer of Ld. Counsel for the petitioner is worth

accepting. In such a situation and considering the nature of reliefs sought by

Ld. Counsel for the petitioner, the Tribunal does not think it necessary to

issue notices to Respondents No. 2 to 4.

5. The claim petition is disposed of, at the admission stage, by

directing the General Manager, Uttarakhand Transport Corporation,

Dehradun to decide the representation of the petitioner by a reasoned and

speaking order, as per law, without unreasonable delay, preferably within 12

weeks of presentation of certified copy of this order along with representation,

enclosing the documents in support thereof. No order as to costs.
