- c. On affidavits, coupons purchased from the District Court shall be affixed.
- d. A fee of Rs. 30/- per affidavit is fixed for the verification of the affidavits.
- e. Failure on the part of Oath Commissioner to comply with any of the aforesaid directions shall entail disqualification, such as removal from the panel or non-consideration for appointment as Oath Commissioner in subsequent years.
