Public Services (Tribunal) Act, 1976, relating to Nainital Jurisdiction [DB] shall be taken up and heard by the Division Bench comprising of Hon'ble Chairman and Hon'ble Vice Chairman(A), virtually, from Dehradun, from 10:15 A.M. onwards, and from 3:30 P.M. onwards, depending upon the convenience of the members of the Bar.

Single Bench matters relating to Dehradun jurisdiction shall be taken up and heard by Hon'ble Chairman at 11:30 A.M. virtually/physically as per mutual convenience of Bar and Bench.

Claim Petitions relating to Dehradun jurisdiction [DB] shall be taken up and heard, virtually (optional), by the Division Bench depending upon the convenience of members of the Bar. Those who are willing to address the Bench, physically, may do so, from 12:30 P.M. onwards [Dehradun jurisdiction].
