Excerpts taken from the Uttar Pradesh Public Services Tribunal Rules of Practice, 1997 (as applicable to Uttarakhand)

Rule 35

During the period of the Tribunal's vacations, the $\overline{\text{Vacation}}$ Judge shall sit on such days and transact such business of urgent priority and unavoidable nature, as the Chairman may specify. The Vacation Judge will be nominated by the Chairman.

During the vacation only those fresh matters which are required to be immediately or promptly dealt with shall, unless directed otherwise, be received in the Registry. The Registry, on being satisfied about the urgency order registration and posting of such cases.

During the vacation, the Registrar may accept CA/rejoinder/Review Petition, etc. in pending/ decided cases (RP) provided a copy of the same has been served on all the other parties/ legal practitioners.

Inspection of record or search may be permitted during vacation according to the rules.

Certified copies of judgements and orders may be supplied during the vacation according to rules.

Steps for issue of notice and for removal of defects in pending matters may also be taken during vacation.
