Claim Petitions relating to Dehradun jurisdiction [DB] shall be taken up and heard, virtually (optional), by the same Bench, upto 12:15 P.M. Those who are willing to address the Bench, physically, may do so, from 12:30 P.M. onwards [Dehradun jurisdiction].

Likewise, Appeals under the Real Estate (Regulation & Development) Act, 2016, shall be taken up and heard, virtually, by the aforesaid Bench, as per mutual convenience of Bar and Bench. Those who are interested in addressing the

Bench, physically, may do so, from 2:30 P.M. onwards.

Single Bench matters relating to Dehradun jurisdiction shall be taken up and heard by Hon'ble Chairman at 2:00 P.M. virtually/physically as per mutual convenience of Bar and Bench

Single Bench matters relating to Nainital jurisdiction shall be taken up and heard by Hon'ble Vice Chairman (A) at 3:00 P.M. virtually from Dehradun.
