JUDGMENT

By means of present claim petition, petitioner seeks the following reliefs:

- "(I) Direct the respondent to decide the appeal dated 06.04.2022 filed by the petitioner for setting aside the punishment order dated 10.02.2022.
- (II) Direct the respondent to decide the representation of the petitioner in terms of para-4 of the claim petition.
- (III) Direct the respondent not to recover the alleged loss from the salary of the petitioner till the disposal of the appeal and refund the recovered amount.
- (IV) To pass any other suitable order, which the Hon'ble Tribunal may deem fit and proper on the basis of the facts and circumstances of the case.
- (V) Award the cost of the petition to the petitioner."
- 2. At the very outset, Ld. A.P.O. objected to the maintainability of the claim petition, *inter alia*, on the ground that the same is premature in view of Section 4(6) of the Uttar Pradesh Public Services (Tribunal) Act, 1976.
- 3. Ld. Counsel for the petitioner, therefore, confined his prayer only to the extent that the departmental appeal of the petitioner dated 06.04.2022 (Annexure: A-1) preferred against the order No.813/VI.M-LPG-484-Enquiry (2019-21) dated 10.02.2022, passed by the Managing Director, G.M.V.N., may kindly be directed to be decided by Respondent No.2, by a reasoned and speaking order, at an earliest possible, in accordance with law. Ld. A.P.O. has no objection to such innocuous prayer.
- 4. The claim petition is, accordingly, disposed of at the admission stage, with the consent of the parties, by directing Respondent No.2 to decide the departmental appeal of the petitioner dated 06.04.2022 (Annexure: A-1), without unreasonable delay, in accordance with law, on presentation of certified copy of this order along with copy of departmental appeal. No order as to costs.

4. It is made clear that the Tribunal has not expressed any opinion on the merits of the case.
