JUDGMENT

This claim petition has been filed seeking the following reliefs:

I. To quash the letter dated 12.07.2019 issued by the General Manager (Administration) Head Quarter Corporation, Dehradun, order dated 09.07.2020 issued by the Assistant General Manager, Uttarakhand Transport Corporation, Bhowali, Nainital and order dated 01.09.2020 issued by the Divisional Manager (Operation) UTC Nainital Division Kathgodam, Nainital, contained Annexure No. 01, 02 and 03 to this claim petition.

II. To direct the respondents to grant the benefits of Ist and IInd ACP in the grade pay of Rs. 2400-2800 to the petitioner as allowed to the other employees in the Uttarakhand Transport Corporation alongwith the consequential benefits.

III. To award any other relief in favour of the applicant which this Hon'ble Tribunal may deem fit and proper in these circumstances of this case.

IV. To award the cost of the petition in favour of the applicant as against the respondents."

2. Counter Affidavit has been filed by the respondent Corporation and Rejoinder Affidavit to the same has been filed by the claim petitioner.

3. The facts in brief of the claim petition are that the petitioner has been awarded the punishment of stoppage of increments (without cumulative effect) a number of times and according to the office order dated 09.07.2020 issued by the Assistant General Manager of the respondent corporation, in his pay fixation, these stoppage of increments have been applied one after the other with the result that the last stoppage of increment of one year ordered on 27.01.2014, has been shown to be effective in the year 2023. The petitioner has not been granted any ACP because of these punishments. The petitioner has brought out the case of many other similarly placed employees of the respondent corporation, who have been granted ACPs even during the pendency of their punishment orders and has also pointed out to certain orders of respondent corporation whereby the punishments of stoppage of increment is not always to be treated to be one after the other and can be treated to run simultaneously also.

4. After hearing learned Counsel for the parties at some length, the Tribunal feels it proper that the petitioner may make a detailed representation to the Managing Director of the respondent corporation stating the various other cases of similarly situated employees which he has obtained through RTI and the Managing Director may ensure that a suitable decision is taken in case of the petitioner in consonance with the similar decisions taken in respect of other employees of the corporation who have been given similar punishments.

5. Order accordingly.

6. The petitioner may make a representation to the Managing Director as above with the certified copy of this order within a period of one month from today and the Managing Director may take suitable decision on the same by passing a speaking and reasoned order within a period of three months thereafter. No order as to costs.
