This claim petition has been filed for the following reliefs:

3. Learned Counsel for the petitioner prays that the representation of the petitioner dated 03.05.2023 may kindly be directed to be decided by the respondent no. 4 within a limited time frame. Learned A.P.O. has no objection to such innocuous prayer of learned Counsel for the petitioner.

In view of the above, the Tribunal directs respondent no. 4 to decide the pending representation dated 03.05.2023 of the petitioner, which is addressed to District Magistrate, Nainital (respondent no. 4) within a period of two months of production of certified copy of this order along with copy of fresh representation, by a reasoned and speaking order. The copy of such order shall also be communicated to the petitioner within the above time limit.
5. With the above directions, the claim petition is disposed of, at the admission stage itself. No order as to costs.
