By means of present claim petition, petitioner seeks the following reliefs:

"(i) Direct the respondents to decide the representation dated 10.04.2024 in connection with grant of increment on actual promotion dated 29.02.2016 as Principal of Govt. Inter

College in accordance with FR-22 (A gazette post, pay scale

Rs. 15600-39100, Grade Pay Rs. 5400/- (Annexure No. A-1).

(ii) To pay the interest on the delayed arrear of unpaid part of salary and delayed arrear on unpaid part of pension,

gratuity, leave encashment etc. @ 12 % per annum.

(iii) To pass any other suitable order, which the Hon'ble Tribunal may deem fit and proper on the basis of facts and

circumstances of the case.

(iv) Award the cost of the petition to the petitioner."

2. After arguing the claim petition at some length, learned

Counsel for the petitioner submitted that the petitioner has already

filed representation to Director, Treasury, Pension & Entitlement, on

10.04.2024, which may kindly be directed to be decided by the said

authority as quickly as possible, in accordance with law.

3. Learned A.P.O. has no objection to such innocuous prayer

of learned Counsel for the petitioner.

4. Without prejudice to rival contentions, the Claim Petition is

disposed of, at the admission stage, with the consent of learned

Counsel for the parties, by directing respondents no. 3 and 4 to

decide the representation of the petitioner, by a reasoned and

speaking order, at the earliest, without unreasonable delay,

preferably within 12 weeks of presentation of certified copy of this

order along with representation enclosing the documents in support

thereof. No order as to costs.
