JUDGMENT

By means of present claim petition, petitioners seek the following reliefs:

"a) To set aside/quash the promotion orders dated 16/05/2018 issued by the Respondent No 1 promoting the respondents No 4 to 8;

b) To direct the respondents not to act on and grant any promotions on the basis of tentative seniority list dated 06/05/2017 issued by the Respondent No 1;

c) To set aside and quash the tentative seniority list dated 06/05/2017 and direct the respondents to draw a fresh tentative seniority list after considering the representations made by the applicant and by placing the applicants in the selection year 2008 - 2009 and by following the principle of rotation of quota as enshrined in Rule 8 (3) of Seniority Regulations 1998; d) To pass any other order/orders, direction/directions that may be deemed fit and proper in the facts and circumstances of the present case. e) Award t he cost of the present petition in favour of the applicants."

2. The claim petition is supported by the affidavit of petitioner. Relevant documents have been filed along with the claim petition.

3. Present claim petition was kept pending for disposal before this Tribunal because Ld. Counsel for the parties had stated, on a number of occasions, that similar controversy, which is involved in present claim petition, is pending adjudication before Hon'ble High Court in WPSB No. 579/2017 and connected writ petitions. They submitted that present claim petition shall abide by the orders of Hon'ble Court in pending writ petitions.
