### **JUDGMENT**

#### **DATED: AUGUST 27, 2024**

#### Justice U.C.Dhyani (Oral)

Present execution application has been filed by the petitioner/applicant for enforcing the order dated 27.02.2024 passed by the Tribunal in claim petition no. 61/SB/2022, Smt. Seema Verma vs. State of

Uttarakhand and others. Operative portion of the judgment dated 27.02.2024 reads as under:

"39. To sum up, the petitioner is entitled to the following:

(i) Interest on delayed payment of pension after one month of death of her husband *i.e.* from 02.01.2019, as per prevalent GPF rate, till the date of actual payment.

(ii) Interest, as per prevalent GPF rate, on delayed payment of gratuity from 02.01.2019, till the date of actual payment.

(iii) Refund of Rs.3,50,608/- which was deducted from the gratuity of her husband, along with interest, as per prevalent GPF rate, from the date deduction was made, till the date of actual payment."

2. It is the submission of Ld. Counsel for the petitioner/applicant that in spite of service of order of the Tribunal, the respondent department has done nothing for compliance of the order dated 27.02.2024.

3. Sri V.P.Devrani, Ld. A.P.O. submitted that no time period was given for compliance of the order. Department is in the process of complying with the said order.

4. In such a situation, the Tribunal deems it proper to remind the respondent department that a duty was cast upon the respondent(s) to do something, which has not been done. Order dated 27.02.2024 passed by the Tribunal in claim petition no. 61/SB/2022 Smt. Seema Verma vs. State of Uttarakhand and others, be complied with, as expeditiously as possible and without unreasonable delay, failing which the respondent, who is responsible for non-compliance of the order, may be liable to face action under the law governing the field.

5. Execution application is disposed of, at the admission stage, with the consent of Ld. Counsel for the parties.
