Petitioners, who are retired Forest Rangers, seek benefit of Rs.5400- grade pay as per Government Order dated 08.03.2011 *w.e.f.* 29.07.2011, in parity with similarly situated employees, along with other consequential benefits, arrears and interest.

2. The claim petition is supported by the affidavit of Sri Ruli Ram

Rathore, petitioner no.1. Relevant documents have been filed along with the

claim petition.

3. It is the submission of Sri Abhishek Chamoli, Ld. Counsel for

the petitioners that similarly situated Forest Rangers have been given benefit

of financial up-gradation and petitioners' representation in respect of the

same is pending decision in the respondent department.

4. Ld. A.P.O. submitted that the representation of the petitioners

has not been decided as yet. It is under consideration of the respondent

department.

5. Ld. Counsel for the petitioner, therefore, submitted that

petitioners' representation may kindly be directed to be decided by the

Conservator of Forest, Yamuna Circle Range, Dehradun, Uttarakhand,

Respondent No.3, as quickly as possible, in accordance with law. Ld. A.P.O.

has no objection to such innocuous prayer.

6. The claim petition is disposed of, at the admission stage, with

the consent of Ld. counsel for the parties, by directing Respondent No.3, to

decide the representation of the petitioners, by a reasoned and speaking

order, as per law, as expeditiously as possible, without unreasonable delay,

on presentation of certified copy of this order along with representation

enclosing the documents in support thereof. No order as to costs.
