## **JUDGEMENT**

# Justice U.C. Dhyani (Oral)

By means of present claim petition, petitioner seeks following reliefs:

"(i) Direct the respondents to issue a reasoned and speaking order in connection of correction of various wrong entries made in service book of the petitioner (Annexure No. A-1).

- (ii) Direct the respondent to release transport allowance as applicable to the field staff and pay the due arrear.
- (iii) Any other order, which the Hon'ble Tribunal may deem fit and proper on the basis of facts and circumstances of the case.
- (iv) Award the cost of the petition to the petitioner."
- Petitioner has filed affidavit in support of his claim petition.
   Relevant documents have been filed with the claim petition.
- 3. It is the submission of Sri Uttam Singh, learned Counsel for the petitioner that the petitioner was given appointment under the U.P. Recruitment of Dependent of Government Servant Dying in Harness Rules, 1974, as Work Supervisor but in his service book, sometimes he is designated as *Seechpal* and on other occasions, *Seechpal* Supervisor and Junior Assistant. The said anomaly requires to be corrected.
- 4. Learned Counsel for the petitioner also submitted that the petitioner is working in field, therefore, he is also entitled to Transport Allowance (T.A.) applicable to the field staff.
- 5. Learned Counsel for the petitioner further submitted that the petitioner is willing to make a representation to the Executive Engineer, Research and Planning, Irrigation Department, Yamuna Colony, Dehradun, respondent no. 5. A direction may be given to the fifth respondent to decide the representation of the petitioner, in a time bound manner, in accordance with law.
- 5. Learned A.P.O. has no objection to such innocuous prayer of the petitioner.
- 6. The claim petition is disposed of, at the admission stage, with the consent of learned Counsel for the parties, by directing respondent no. 5 to decide the representation of the petitioner by a reasoned and speaking order, as expeditiously as possible, in accordance with law, on presentation of certified copy of this order

along with representation enclosing the documents in support thereof. No order as to costs.

7. Rival contentions are left open.
