### **JUDGEMENT**

**Dated: 16th July, 2024** 

## Justice U.C. Dhyani (Oral)

By means of present claim petition, petitioners seek following reliefs:

"(i) direct the respondent nos. 1 & 2 to provide seniority to the petitioners from the initial date of their joining, i.e. 07-11-2008, 15-01-2009 & 07-11-2008; and further, direct the respondent no. 2 to amend the seniority lists dated 27-01-2024 & 16-02-2024 as per the initial date of joining of petitioners in the department.

- (ii) issue any other suitable order or direction in favour of petitioners, which this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the present case.
- (iii) award cost of claim petition in favour of petitioners."
- 2. Learned Counsel for the parties submitted that the controversy in hand has been resolved by Hon'ble High Court on 27.06.2024 in WPSB No. 579 of 2017, Uttarakhand Power Corporation Limited vs. B.M. Bhatt and others, with connected writ petitioners, therefore, present claim petition may be disposed of in terms of the above-noted writ petitions decided by the Hon'ble High Court.
- Para 22 of the aforesaid decision reads as under:
  - "22. In view of the above discussion, the present Writ Petitions are being allowed. The order of the Tribunal is being set-aside. A direction is being given to Uttarakhand Power Corporation ltd. to fix the seniority after giving the benefit of seniority to all the Assistant Engineers, who joined in the year 2006-07, 2007-08 & 2008-09 from the date of their joining the department, and keeping in view the rota quota between the direct recruits and the promotes. The entire exercise shall be completed with a period of eight weeks from the date of production of a certified copy of this judgement."
- 4. Since the controversy involved in present claim petition has been decided by the Hon'ble High Court, as above, therefore, present claim petition is being deposed of in terms of the aforesaid judgement/ order of the Hon'ble Court, at the admission stage, with the consent of learned Counsel for the petitioners and respondents no. 1 and 2.
- 5. Learned Counsel for the parties submitted that such an order may be passed by Single Bench of the Tribunal.
- 6. No useful purpose would be served by issuing notices to the private respondents, hence, the same is not being done. They may represent their case before the respondent-Corporation, if they feel, they have something to gain out of the above-noted decision of the Hon'ble High Court.

7. The claim petition is thus disposed of, in terms of the aforesaid decision of the Hon'ble High Court, at the admission stage, with the consent of learned Counsel for the parties. No order as to costs.
