JUDGMENT

Justice U.C.Dhyani (Oral)

By means of present claim petition, petitioners seek the following reliefs:

- "(i) To issue an order or direction to the respondents to pay the outstanding dues and pension and arrears of the pension of Late Sh. Kishor Singh Chauhan to the petitioner with interest on the above dues @ 10% per annum since the date of death of Sh. Kishor Singh Chauhan till the date of actual payment.
- ii) To issue any other order or direction which this court may deem fit and proper in the circumstances of case in favour of the petitioner.
- iii) To award the cost of petition."
- 2. The claim petition is supported by the affidavits of legal guardians and custodians Sri Mahendra Singh Chauhary and Smt. Rajeshwari Devi. Relevant documents have been filed along with the same.
- 3. The Bench has been taken through different orders obtained from different Hon'ble Courts along with other documents, to submit that two letters dated 23.04.2024 (Annexure: A-7) and 26.03.2024 (Annexure: A-6), written by the Block Education Officer to Principal, Govt. Inter College, Tehri Garhwal and by Chief Education

Officer, Tehri Garhwal to Block Education Officer, Tehri Garhwal,

regarding settlement of family pension and other dues were sent, but

there is no response from the said authorities so far. Ld. Counsel for

the petitioner prayed that a direction be given to the authorities

concerned to take appropriate decision on these letters, as per law.

Ld. A.P.O. has no objection to such innocuous prayer.

4. The claim petition is disposed of, at the admission stage,

with the consent of Ld. counsel for the parties, by directing

Respondents No. 4 & 5 to take a decision on the letters, which were

sent to them and a reference of which has been given as above, as

expeditiously as possible and without unreasonable delay, on

presentation of certified copy of this order along with copies of above

noted documents.
