### **JUDGMENT**

### **DATED: OCTOBER 23, 2024**

#### Justice U.C.Dhyani (Oral)

Above-noted claim petitions were decided together *vide* judgement and order dated 16.01.2024. The parties, subsequently, noted that Director, Secondary Education, Uttarakhand, was not a proper party against whom the directions were given in Tribunal's order dated 16.01.2024. They found that Director, Elementary Education, Uttarakhand, was, in fact, proper party. The petitioners moved amendment application, which was allowed. Order dated 16.01.2024 was kept in abeyance.

2. Director, Secondary Education, Uttarakhand, was substituted by Director, Elementary Education. An affidavit was filed on behalf of newly added respondent. In such affidavit, almost the same facts were mentioned, which were mentioned in the counter affidavit on behalf of Director, Secondary Education.

3. The claim petitions were opposed. Learned A.P.O. submitted, on the basis of the C.A. thus filed on behalf of Director, Elementary Education, that claim petitions lack force and are liable to be dismissed.

4. Nevertheless, learned Counsel for the parties submitted that even if Director, Secondary Education, is substituted by Director, Elementary Education, as party respondent, the fate of both the claim petitions will remain the same.

5. In other words, the text of the decision dated 16.01.2024 would remain the same notwithstanding the fact that Director, Secondary Education, has been replaced by Director, Elementary Education, with same set of facts (assertions) and with similar objections.

6. Learned Counsel for the parties, therefore, submit that the Tribunal should reiterate its earlier decision (dated 16.01.2024) to avoid repetition and for the sake of brevity and convenience, with fresh direction to the newly substituted Director, Elementary Education [in place of Director, Secondary Education, who was party respondent when the Tribunal decided the claim petitions earlier].

7. The claim petitions are, accordingly, disposed of, with the consent of learned Counsel for the parties, with the same terms of settlement and same directions, which were mentioned in Tribunal's earlier order dated 16.01.2024.
