## **JUDGMENT**

## **DATED: FEBRUARY 19, 2025**

Learned Counsel for the petitioners-executioners submitted that despite repeated orders of this Tribunal, respondents have not complied with the judgment and order dated 18.05.2023 of this Tribunal. He has submitted that the respondents neither filed the compliance affidavit nor filed the stay order against the judgment of this Tribunal. He further submitted that such conduct of the respondents is liable to be contemptuous.

Learned A.P.O. submitted that he has not received further instructions from the Department for compliance and further submitted that writ petition filed by the Department against the judgment and order dated 18.05.2023 passed by this Tribunal is still pending before the Hon'ble High Court of Uttarakhand at Nainital.

Learned Counsel for the petitioners-executioners requested that execution application may be disposed of with a liberty to file contempt petition against the respondents.

In view of above and perusal of the records reveal that the respondents have already been given sufficient opportunity to comply with the Tribunal's order dated 18.05.2023, but they have failed to comply with the same and by not complying the Tribunal's order, shows disobedience on the part of the respondents.

Hence, the aforesaid execution applications are disposed of with liberty to the petitioners/executioners to file contempt petition, as prayed.
