JUDGMENT

DATED: OCTOBER 05, 2016

(Hon'ble Mr. Ram Singh, Vice Chairman (J)

- 1. The present claim petition has been filed by the petitioner for the following relief:
 - "a) to quash and set-aside the impugned order dated 13.01.2015 (Annexure No. 1) issued by the respondent no. 4.
 - b) to direct the respondent no. 2 and 3 to re-determine the seniority of the applicants in accordance with their merit in the select list of the selection of Forest Guard held in the year 1995 as per rule 21 of the Uttarakhand (U.P. Lower Subordinate Forest Service Rules 1980).
 - c) to grant promotion to the applicants on the post of Forester from the date when persons selected pursuant to the selection held in the year 1995 for the post of Forest Guard were promoted as Foresters alongwith all consequential benefits including arrears of salary.
 - d) to pass any other suitable order as this Hon'ble Tribunal may deem fit and proper under the facts and circumstances of the case.

- e) to award the cost of the petition in favour of the applicant."
- 2. The facts given rise to the petition are that the respondent no. 4 in the year 1995 selected 15 persons for the post of Forest Guards as per select list (Annexure-3) in which the petitioners were ranked at sl. No. 6, 7, 11 and 9 respectively. The successful candidates were to be appointed after medical examination. The record reveals that vide order dated 23.12.1995, the respondent has issued appointment letters of the selected persons ranked in the select list at sl. No. 1, 2, 3, 4 & 8 respectively. The remaining persons could not get their appointment in view of Government Order dated 01.12.1995 whereby appointment on all Class-III and Class IV posts were stopped with immediate effect. However, five persons were given appointment by the respondents taking the stand that government order was received in the office on 01.01.1996 and after receipt of the said G.O., other 10 candidates who produced their medical certificates after 01.01.1996 were not appointed.
- 3. Feeling aggrieved by the attitude of the respondents, the petitioner no. 1 filed a writ petition no. 14509 of 1997 before the Hon'ble High Court of Allahabad, which was subsequently transferred to Hon'ble High Court of Uttarakhand at Nainital after creation of the State of Uttarkahand and was renumbered as W.P. No. 3806(S/S) of 2001. The said writ petition was decided on 14.05.2003 with the direction to the respondents to give appointment to the petitioner no. 1. The petitioners no. 2 to 4 also filed writ petitions bearing no. 1402 of 2003 (S/S), 1401 of 2003 (S/S) and 1403 of 2003 (S/S) respectively before the Hon'ble High Court of Uttarakhand. Similarly, the said writ petitions were also decided with the same direction to the government. Consequently, in compliance of the order of the Hon'ble High Court, the petitioner no. 1 was appointed on the post of Forest Guard on

21.10.2003 and the petitioners no. 2 to 4 were also appointed vide order dated 23.1.2004. Thereafter, a tentative seniority list of the Forest Guards at State Level was prepared and the same was circulated by the respondent in which the seniority of the petitioners was given on the basis of their date of joining the services, i.e. the date of substantive appointment actually made, against which the petitioners filed their objections taking the ground that since they were selected in pursuance to the selection held in the year 1995, as such their seniority be placed with the persons appointed on the basis of the same select list of 1995. The objections of the petitioners dated 25.10.2004 were disallowed by the respondents vide letter dated 13.01.2015 (Annexure No. 1). The persons selected at sl. No. 1 to 4 and 8 were shown at sl. No. 565 to 569 in the seniority list whereas, the petitioners' seniority has been shown at sl. no. 1042, 1190, 1191 and 1192 respectively.

4. The petitioners have challenged the seniority list solely on the basis that as per the provisions of the Uttarakhand (U.P. Lower Subordinate Forest Service) Rules 1980 as modified vide Uttarakhand Notification dated 08.02.2003, the seniority has to be determined as per Rule-21 and according to the proviso of Rule 21, the inter-se seniority of the persons directly appointed to the service shall be the same as determined at the time of their selection. As the petitioners were selected in the select list of 1995, hence their seniority should be placed with the persons selected by a common selection in 1995 mentioned at sl. no. 565 to 569 in the seniority list. The petitioners have also pleaded that in a similar matter of Manohar Chandra Pandey, the writ petition was filed before the Hon'ble High Court and that writ petition was allowed by the Hon'ble High Court with the direction to the respondents to fix the seniority as per proviso of Rule 21 and the forest department consequently, amended the seniority list. The petitioners in their representation specifically mentioned that the petitioner no. 1 was ranked at sl. No. 6 in the select list, whereas, Deep Chandra Upreti was ranked at sl. No. 8, but now he has been shown at sl. No. 565 in the seniority list, whereas, the petitioner's seniority has been placed at much lower rank in the seniority list, which is against the provisions of law. Hence this petition.

- 5. The respondents have contested the petition admitting the fact that out of 15 persons selected in the list, only 5 persons were appointed on 23.12.1995 and remaining 10 persons could not be appointed in view of the ban put on appointment of Class-III and IV by the government vide order dated 01.12.1995, the copy of which was received on 01.1.1996 and the petitioners and other person did not produce their medical and other certificates in time so they were not appointed at that time and later on, in compliance of the order of the Hon'ble High Court, their appointment was made in the year 2003 and 2004. The seniority of the Forest Guards were fixed Division-wise, but after amendment in the Subordinate Forest (Rangers, Deputy Rangers and Foresters) Service Rules, 1951 as adopted by the State of Uttarakhand in 2002 and amended in 2011, the promotion on the post of Foresters were to be made from the post of Forest Guard. Hence, seniority list of the Forest Guards is to be maintained at the State level and according to the Uttarakhand Government Servants Seniority Rules, 2002 and concerned Uttarakhand (U.P. Lower Subordinate Forest Service) Rules 1980, the seniority has to be fixed from the date of substantive appointment. Accordingly, the petitioners have rightly been placed and the petition deserves to be dismissed.
- 6. The petitioners have filed rejoinder affidavit reiterating the same facts as have been stated in the petition. It was further contended that the contention of the respondents in paragraph no. 2 of their C.A. are erroneous and misleading. It is wrong to say that the petitioners

were under obligation to produce their documents before their appointment because the respondent no. 4 had directly written a letter dated 20.12.1995 to Chief Medical Superintendent of Soban Singh Jeena Base Hospital, Haldwani with the request to conduct the medical examination of all the selected candidates and to furnish the measurement and health certificates of all the selected candidates to respondent no. 4 so that appointment letters could be issued. All the selected candidates including the petitioners were directed to appear before the Chief Medical Superintendent for the medical checkup. All selected candidates had appeared before the CMS for medical checkup on the same day. The measurements and medical certificates of the selected candidates were to be sent by the CMS directly to the respondent no. 2 and the petitioners were not required to submit the same at their own. The cause of action to the petitioners only arose when the tentative seniority list was circulated and the petitioners filed their objections within time, which were not considered by the respondents and the final seniority list was issued. It was further reiterated that proviso-1 of Rule 21 clearly says that inter-se seniority of the persons directly appointed shall be the same as determined at the time of their selection, whereas, the respondent has acted against the provisions of law and the impugned seniority list is liable to be set aside.

- 7. We have heard learned counsel for the petitioner as well as learned A.P.O. for the respondents no. 1 to 4 and perused the record carefully. None has appeared for the respondents no. 5 to 605.
- 8. The seniority is a statutory right governed by the statute and the respondents cannot evolve its own method to determine the seniority contrary to the statute. The issue in the present case is as to how the seniority of the petitioners should be ascertained. It is admitted fact that the petitioners were selected by a common selection in the

year 1995 with the persons mentioned at sl. No. 565 to 569 in the impugned seniority list issued on 10.12.1995. Annexure No. 3, is the list of the persons selected at that time which clarifies that the petitioner no. 1, Nain Singh was ranked at sl. No. 6, Sunder Lal at sl. No. 7, Jagesh Verma at.sl. no. 9 and Harish Ram at sl.no. 11. The appointment letter issued on 23.12.1995 (Annexure: R-3) clarifies this fact that five persons appointed vide order dated 23.12.1995 were not picked up as per merit list because the 5th person, Deep Chandra Upreti ranked at sl. No. 8, whereas, the petitioners, Nain Singh and Sunder Lal ranked at sl. no. 6 and 7 of merit list and one other person, Vishan Ram ranked at sl. No. 5, was left out from appointment. The reasons shown by respondents for not appointing all the persons as per the select merit list is not convincing because the respondents have taken the help of government order dated 01.12.1995 (Annexure No. 2) by which the recruitment of Class-III & Class-IV was stopped by the government in compliance of the order of Hon'ble High Court with immediate effect and it was specifically mentioned that after the date of judgment dated 29.09.1995, no appointment to class-III and class-IV should be made or carried out. The respondents applying the policy of pick and choose, and in disregard to the government order, appointed five persons on 23.12.1995, whereas such appointment was banned since the date of judgment dated 29.09.1995 and furthermore, it was specifically banned by the government vide order dated 01.12. 1995. The only excuse taken by the government had been that they were not having knowledge of the government order 01.12.1995 and the judgment dated 29.09.1995, hence, appointment was issued on 23.12.1995 after 23 days of order of ban.

9. Aggrieved by the discriminatory action of the respondents, the petitioner no. 1 approached to the Hon'ble High Court of Allahabad in writ petition no. 14509 of 1997, which was subsequently transferred

to the Hon'ble High Court of Uttarakhand at Nainital after creation of the new State and was renumbered as 3806(S/S) of 2001. The said writ petition was decided on 14.05.2003 (Annexure: 4) with the direction to the respondents to pass appropriate order for appointment of the petitioner as Forest Guard, ignoring the plea that there is any ban imposed by the government on making appointment on Group-C and Group-D posts because some other person Sri Ganesh Lal Shah was given appointment by the respondent on 30.07.2001. In compliance of the said order, the petitioner no. 1 got his appointment in 2003 and other petitioners, who got similar order on their writ petitions were given appointment vide order dated 23.1.2004. The action of the government, appointing some of the persons and denying the appointment to the petitioners cannot be justified because the similarly situated persons were treated differently. The reason submitted by the respondents, in not appointing the remaining persons was that, they did not produce their medical examination certificates in time. This has been denied by the petitioners by their affidavit. The record reveals that the respondents issued a letter on 20.12.1995 (Annexure: R-10) to Chief Medical Superintendent, Soban Singh Jeena Base Hospital, Haldwani to conduct medical examination of selected 15 persons named in the list and to inform about the result of their medical examination. In the same letter, the petitioners were directed to appear before the CMS. There was no such direction for the petitioners or any of the selected candidates, to get their medical certificates and submit the same personally before the appointing authority. Hence, it was obligation of CMS to send the medical examination certificates of the selected candidates directly to the respondent no. 4. It is submitted in the counter affidavit that all the persons selected in the list, appeared for their medical examination on the same day before the CMS and they were medically examined same day. Hence, in these circumstances, there exists no reasonable ground to explain, why the discrimination

was made against the petitioners for issuing the appointment letter and why the pick and choose policy was adopted. Finding all these facts, the Hon'ble High Court allowed their writ petitions and respondents were directed to appoint the persons selected in the select list of 1995 and they could get their appointment in 2003 and 2004 respectively after a long litigation. Hence, the petitioners cannot be made to suffer on account of discriminatory behavior of the respondents. Putting all these facts together, learned counsel for the petitioners has further argued that inspite of all these discriminations, the law requires that their seniority should be fixed with the persons who ranked with them in the same select list and particularly above the persons who ranked junior to the petitioners.

10. The relevant Rules for deciding the seniority is the Uttarakhand (U.P. Lower Subordinate Forest Service) Rules 1980 as modified vide Uttarakhand Notification dated 08.02.2003. Rule 21 of the said Rules reads as follows:

"Rule 21: Seniority- Seniority in any category of post in the service shall be determined from the date of order of substantive appointment and if two or more persons are appointed together from the order in which their names are arranged in the appointment order:

Provided that;

- (1) The inter se seniority of persons directly appointed to the service shall be the same as determined at the time of selection;
- (2) The inter se seniority of persons appointed to the service by promotion shall be the same as it was in the substantive post held by them at the time of probation"

Rule-8 (2)(a) of the Uttarakhand Government Servants Seniority Rules, 2002, reads as under:

- "(2) (a)- The seniority inter se of persons appointed on the result of any one selection-
- (a) through direct recruitment, shall be the same as it is shown in the merit list prepared by the Commission or by the merit list prepared by the Commission or by the Committee, as the case may be.
- (b)"
- 11. The particular rule applicable in the case of the petitioners is Rule 21 of the said Rules and Rule 8(2)(a) of the Uttaranchal Government Servants Seniority Rules, 2002, which has been relied upon by the petitioners as well as by the respondents. Learned counsel for the respondents has argued that the seniority list has been fixed as per the Rule-21 according to the date of substantive appointment. According to respondent, as the substantive appointments of the petitioners were made in 2003 and 2004 hence, they were given seniority with that date. Learned counsel for the petitioners has argued that in their case, the Proviso-1st of the Rule 21 would apply.
- 12. We are of the view that the basic principle as per first part of Rule 21 is that the seniority shall be given from the date of substantive appointment, but the first proviso, which overrides the general rule, specifically says that the inter-se seniority of the persons directly appointed to the service shall be the same as determined at the time of selection. Hence we agree with the argument of the learned counsel for the petitioners that the petitioners cannot be placed at lower rank in the seniority list with the persons who ranked junior to them in same select list prepared on 10.12.1995 (Annexure: 3), according to which, it

is very much clear that Deep Chandra Upreti who was placed at sl. No. 8 in the combined selection list of 1995 is now placed at sl. No. 565 whereas, petitioner No. 1, Nain Singh, petitioner no. 2, Sunder Lal, who were placed at sl. No. 6 & 7 and other petitioners placed at sl. no. 9 & 11 in the select list, have been wrongly placed at sl. No. 1042, 1190, 1191 and 1192 in the impugned seniority list. Hence, we are of the view that the seniority list prepared by the respondents clearly violates the provisions of Proviso-1 of Rule 21 of the said Rules.

- 13. Learned counsel for the petitioner has also cited an example of other person Manohar Chandra Pandey, whose case was similar to the petitioners and he was placed lower in the seniority, had approached the Hon'ble High Court by way of writ petition and his petition was allowed and the appointing authority was directed to place his seniority with the persons selected by a common select list. The copy of the judgment of Hon'ble High Court is as Annexure No. 1. Accordingly, in compliance of that order, the Forest Department modified the seniority list. Petitioners case is similar on facts. Hence, we agree with the argument of learned counsel for the petitioners that the respondents cannot be permitted to evolve its own method to determine the seniority list contrary to the provisions of law.
- 14. Leaned counsel for the respondents has also argued that the petitioners have come up before the Tribunal after a period of 13 years because they did not file any objection in the year 2003 and 2004 when they were appointed. Learned counsel for the petitioners has replied to this plea that their grievance arose first time when the seniority list was issued in 2014 and they objected to the same without any delay. Hence in our opinion, no delay has been caused on the part of the petitioners.
- 15. We are of the view that the petition deserves to be allowed and the impugned order dated 13.01.2015 by which seniority list had been

issued by the respondent no. 4 deserves to be set aside and it is necessary that the petitioners should be placed in their seniority among the persons selected by a common select list and the seniority should be determined as per the merit which was at the time of their selection. The petitioners have also asked for the relief of consequential promotion on the post of Foresters on the basis of their new place of seniority as per law to which they deserve to be considered to which they are entitled.

ORDER

The claim petition is allowed. The impugned order dated 13.1.2015 issued by respondent no. 4 is hereby quashed. The respondents are directed to re-determine the seniority of the petitioners in accordance with their merit in the selection of Forest Guards held in the year 1995 as per Rule 21 of the Uttarakhand (U.P.
