#### JUDGMENT

# Justice U.C.Dhyani (Oral)

By means of Claim Petition No. 101/DB/2023 , petitioner prays for the following reliefs:

- "i. To declare the petitioner as substantive and regular and grant the pay scale of Rs. 9300-34800 grade pay Rs. 4600 revised to Rs. 44900-142400 (Level-7) taking count of his ad-hoc services with all service intakes and benefits in terms of the Government Order dated 09.03.2019 or to mould the relief appropriately keeping in view that facts highlighted in body of the petition.
- ii. To issue any other suitable order or direction which this Hon'ble Tribunal may deem fit and proper in the circumstances of the case.
- iii. To award the cost of the petition to the petitioner."
- 2. Claim petition is supported by the affidavit of the petitioner. Relevant documents have been filed along with the petition.
- 3. In Claim Petition No. 106/DB/2023 , petitioners seek the following reliefs:
  - "I. Issue order, rule, declaration or direction directing respondents to treat the entire length of ad-hoc services from their respective dates mentioned in paragraph no. 4.2 to 05.05.2017, as substantive and regular service and as well as qualifying service for the purpose of ACP/MACP, pension and other service intakes, in light of GO dated 09/03/2019 and to refix the pay of the petitioners and also to pay consequential benefits like arrears of pay and other benefits, or to mould the relief appropriately, keeping in mind the facts highlighted in the body of the petition.
  - II. To grant damages and the compensation for being subjected to illegal act by the respondents in tune of such amount which the Court may deem fit and proper in the circumstances of case in favour of the petitioner and same may be recovered from the erring officers.
  - III. To award the cost of petition."
- 3. Claim petition is supported by the affidavit of the Petitioner No.1 Sri Vinod Kumar Raturi. Relevant documents have been filed along with the petition.
- 4. Claim Petitions have been contested on behalf of respondents. Sri Prem Singh Nabiyal, Senior Staff Officer, Office of Engineer-in-Chief, Public

Works Department, Uttarakhand, Dehradun has filed Counter Affidavits on behalf of Respondents in both the claim petitions. A document has also been enclosed with the C.A. filed in Claim Petition No. 101/DB/2023.

- 5. In claim petition No. 101/DB/2023, an application for taking certain documents on record was filed by the petitioner along with an affidavit. Such documents were taken on record.
- 6. Since common questions of law and facts are involved in these claim petitions, hence, they are heard together and are being decided by a common judgment and order for the sake of brevity and convenience.
- 7. Today, Sri M.C.Pant, Ld. Counsel for the petitioners, placed a copy of the Govt. Order dated 06.02.2025 on record, to submit that G.O. dated 09.03.2019 has been clarified in G.O. dated 06.02.2025, as follows:

It is clear from the above that the time scale that the service period prescribed for admissibility of benefits under Pay Scale/ACP/MACP should be calculated from the date of regular appointment of the concerned employee. In this, the services rendered on contractual, daily wage, fixed salary, seasonal, adhoc basis will not be taken into consideration. After regular appointment on any permanent/temporary created post, if any employee is appointed on higher post or equivalent post as substitute, ad-hoc, in-charge arrangement, then in such a case the services of the said period will be taken into consideration. That is, the continuous services rendered in ad-hoc, in-charge or officiating capacity between two regular appointments will be taken into consideration Will be taken into calculation for existing scale/ACP/MACP.

It is clear from the above that the service period prescribed for admissibility of benefits under Time Scale Pay Scale ACP/MACP should be calculated from the date of regular appointment of the concerned employee. In this, the services rendered on contractual, daily wage, fixed salary, work-charged,

seasonal, ad-hoc basis will not be taken into account. After regular

appointment on a permanent/temporary created post, if any

employee is appointed on a higher post or equivalent post as

substitute, ad-hoc, in-charge arrangement, then in such a case,

the services of the said period will be taken into account in relation

to the original post, i.e., the continuous services rendered as ad-

hoc, in-charge or officiating between two regular appointments will

be taken into account for Time Scale Pay Scale/ACP/MACP.

In addition to the above, ad-hoc recruitment for higher post

or in the event of promotion to the same post while working in the

pay scale of a higher post in an officiating capacity, the continuous

services rendered in an ad-hoc or officiating capacity in view of

continuing to work in the same pay scale/grade pay/pay level will

also be taken into account for time scale pay/ACP/MACP relative

to the higher post.

8. The controversy involved in present claim petitions is covered by

the latest G.O. dated 06.02.2025, which has clarified earlier G.O. dated

09.03.2019 on the same subject matter.

9. Both the claim petitions are, accordingly, disposed of in terms of

G.O. dated 06.02.2025, with all consequential service benefits. Respondent

department is directed to implement the G.O. dated 06.02.2025 in respect of

the petitioners, as expeditiously as possible and without unreasonable delay,

preferably within 12 weeks of presentation of certified copy of this order

along with copy of the relevant G.O. No order as to costs.
