**JUDGMENT**

**Justice U.C.Dhyani (Oral)**

By means of present claim petition, petitioners seek  
the following reliefs:

“ I) To direct the respondent No.2 to decide the representation of  
the petitioner (Annexure: A-1).

II)To pass any other suitable order, which the Hon'ble Tribunal may  
deem fit and proper on the basis of facts and circumstances of the  
case.

III)Award the cost of the petition to the petitioner.”

2. The claim petition is supported by the affidavit of the petitioner. Relevant documents have been filed along with the same.

3. The only prayer of the petitioner, in claim petition, is to direct Respondent No.2 to decide pending representation of the petitioner. In her representation dated 06.05.2025 (Annexure: A-1), the petitioner has sought some relief from the Director General, Medical, Health and Family Welfare (Respondent No.2). According to Sri Uttam Singh, Ld. Counsel for the petitioner, decision on such representation is awaited. He submitted that a direction be given to the Respondent No.2, to decide such representation of the petitioner, in accordance with law. Ld. A.P.O. has no objection to such innocuous prayer.

4. The claim petition is disposed of, at the admission stage, with the consent of Ld. counsel for the parties, by directing Director General, Medical, Health and Family Welfare, Dehradun, Uttarakhand, Respondent No.2, to decide pending representation of the petitioner, by a reasoned and speaking order, in accordance with law, as expeditiously as possible and without unreasonable delay, on presentation of certified copy of this order, enclosing the documents in support of her representation. No order as to costs.

5. Rival contentions are left open.
