JUDGMENT

Justice U.C.Dhyani(Oral)

In claim petition no. 05/SB/2017, this Tribunal directed, on 02.03.2017, as under:

"The claim petition is hereby allowed. Respondents are directed to refund the amount of Rs.17,766/- recovered from the petitioner. Respondents are also directed to pay to the petitioner (i) interest

on monthly pension from 01.05.2012 till the date of actual payment;

(ii) interest on gratuity from 01.05.2012 till the date of actual

payment; and (iii) interest on the amount of leave encashment from

01.05.2012 till the date of actual payment. The rate of interest shall

be the simple rate of interest payable on General Provident Fund

during the relevant period. The petitioner will be paid recovered

amount of Rs.17,766/- and the amount of interest as above within a

period of three months from the date of copy of this order is

received by the respondents. No order as to costs."

2. When the order was not complied with, the petitioner was

compelled to file present contempt petition. It is the submission of Ld.

A.P.Os. that the order sought to be enforced has been complied with.

Ld. A.P.Os. also submitted that Sri R.C.Srivastava, Director,

Horticulture, has already directed Chief Horticulture Officer,

Dehradun, vide letter No.3129 Court Case(T)-18/2018-19 dated

01.01.2019 to comply with the order of the Court, a copy of which has

been placed before this Tribunal to show that the interest on delayed

payment of gratuity has already been sanctioned and formality of

disbursing money is to be completed by Chief Horticulture Officer. In

all likelihood, the same should be disbursed to the petitioner within a

fortnight.

3. Since the order sought to be enforced has been complied with,

therefore, we do not think we should continue with present contempt

petition. The contempt petition is, accordingly, closed. Notices issued

to the respondents are discharged. Liberty is, however, granted to the

petitioner to make a mention, if the money is not disbursed in his

favour within a fortnight.
