Two more intervention applications have been filed by Dr. N.K.Pant, Advocate, on behalf of Sri Trepan Singh and Sri Arun Vikram Singh. Ld. Counsel for the petitioner seeks and is granted time up to 08.07.2020 to file objections to the same.

Sri B.B.Naithani, Ld. Counsel for Uttarakhand Jal Sansthan seeks a very short date to place the Rule Position before the Tribunal. Sri Naithani is permitted to do so by 08.07.2020.

Written submissions have been filed on behalf of petitioner, private respondents and Ld. A.P.O. The same are taken on record.

Heard submissions of Sri M.R.Saklani, Ld. Counsel for the petitioner; Sri V.P.Devrani, Ld. A.P.O.; and Sri Deepak Singh Ld. Counsel for Respondents No. 4 to 7, at some length. Also heard Sri

M.C.Pant, Advocate for intervener Sri Ashish Bhatt as well as Dr. N.K.Pant, Advocate for interveners Sri Trepan Singh and Sri Arun Vikram Singh.

Since most of the Counsel seek further time, to place their case on one pretext or another, therefore, it will be in the interest of justice, if 08.07.2020 is fixed for remaining arguments.
