By means of present claim petition, petitioners seek, following reliefs:

- (i) Issue an order or direction calling for the record and to grant the promotion from the date of their eligibility.
- (ii) Issue an order or direction calling for the record of granting promotion to the petitioner.

(iii) Issue an order directing the respondent to grant the promotion from the date of eligibility of the petitioners with arrears and 9

percent interest.

(iv) Issue any suitable claim, order or direction which this Hon'ble

Tribunal may deem fit and proper in the circumstances of the

case.

time was granted to the respondent to file C.A./W.S.. The claim petition

was directed to be listed on 12.08.2020.

directed to be decided by respondent, at an early date, in accordance

with law, to which. Ld. A.P.O. has no objection.

4. Claim petition is, accordingly, disposed of, by directing Principal

Secretary/ Secretary, to the Government in Secretariat Administration

Department, to decide the pending representations dated 11.05.2020

and 13.05.2020 (Annexure: 1 and 2 of the claim petition) of the

petitioners, by a reasoned and speaking order, in accordance with law, at

the earliest possible, but not later than six weeks of presentation of

certified copy of this order along with copy of representations.
