JUDGMENT

By means of present execution petition, the petitionerexecutioner seeks to punish the respondents/ opposite parties for willful disobedience of the judgment and order dated 09.07.2020, passed by this Tribunal in claim petition No. 30/DB/2020.

2. The order sought to be executed is being reproduced herein below for convenience:

"Claim petition is, accordingly, disposed of, by directing Principal Secretary/ Secretary, to the Government in Secretariat Administration Department , to decide the pending representations dated 11.05.2020 and 13.05.2020 (Annexure: 1 and 2 of the claim petition) of the petitioners, by a reasoned and speaking order, in accordance with law, at the earliest possible, but not later than six weeks of presentation of certified copy of this order along with copy of representations."

- 3. Ld. Counsel for the petitioner/ executioner, submitted that despite service of order dated 09.07.2020 along with letter dated 13.07.2020, upon the Respondent, the same has not been complied with so far.
- 4. It is the submission of learned counsel for the petitioner/ executioner that the casual approach on the part of opposite party/respondent should not be tolerated and strict action should be initiated against him.
- 5. Ld. A.P.O. appearing on behalf of opposite party prays for and is granted six weeks' time to comply with the order of the Tribunal.
- 6. This Tribunal directs the authority concerned to comply with the same within six weeks (from today), failing which, the opposite party may be liable to face appropriate action under the relevant law governing the field.
- Petitioner/ executioner is directed to place a copy of this order, as also the order dated 09.07.2020 before the authority concerned , by 01.09.2020, to remind that a duty is cast upon said authority to do something, which has not been done.
- 8. The execution petition is, accordingly, disposed of.
